Purpose of this notice

This notice provides you with the opportunity to comment directly to the developer on the proposed development prior to the actual submission of the retrospective planning application to the local planning authority ("LPA"). Any subsequent planning application will also be publicised and consulted upon by the LPA. Please note any comments provided in response to this notice will not prejudice your ability to make representations to the LPA on any related planning application.

Gareth and Janet Jones are applying for retrospective planning permission for the retention of the Fishing Lake, Fisherman's Hut and ancillary works at the above site. Planning permission was granted for a lake and hut on the 30th January 2018 however the lake and hut were not built in accordance with the approved plans. The Local Planning Authority now require them to apply for retrospective planning to retain the lake in its current position and the hut.
